TERMS AND CONDITIONS FOR ACCMMODATION CONTRACTS

Article1 (Scope of Application)

1.Contracts for Accommodation and related agreements to be enter into between thi s Ryokan/Hotel and the Guest to be accommodated shall be subject to these Terms and Conditions.

And any particulars not provided for herein shall be governed by laws and regulati ons and/or generally accepted practices.

2.In the case when the Ryokan/Hotel has enter into a special contract with the Gue st insofar as such special contract does not violate laws and regulations and general ly accepted practices, notwithstanding the preceding Paragraph, the special contract shall take precedence over the provisions of these Terms and Conditions.

Article2(Application for Accommodation Contracts)

1. The Guest who intends to make an application for an Accommodation Contract w ith the Ryokan/Hotel shall notify the Ryokan/Hotel of the following particulars; (1) Name of Guest(s):

(2) Date of accommodation and estimated time of arrival;

(3) Accommodation Charges (based, in principle, on the Basic Accommodation

Charges listed in the attached Table No.1); and

(4) Other particulars deemed necessary by the Ryokan/Hotel.

2. In the case when the Guest requests, during his stay, extention of the accommo dation beyond the date in Subparagraph (2)of the preceding Paragraph, it shall be r egarded as an application for a new Accommodation Contract at the time such request is made.

(Regarding food allergy)

We will do everything we can to make sure you have a safe meal. But some of pr ocessed foods such as eggs, milk, wheat, shrimp, crab, buckwheat and peanuts are not obligated to be labeled and we cannot be confirmed.

Therefore, please note that we may not be able to prepare meals.

Article3(Conclusion of Accommodation Contracts, etc.)

1.A Contract for Accommodation shall be deemed to have been concluded when th e Ryokan/Hotel has duly accepted the application as stipulated in the precedinig Ar ticle. However, the same shall not apply when it has been proved that the Ryokan/Hotel has not accepted the application.

2.When a Contract for Accommodation has been concluded in accodance with the p rovisions of the preceding Paragraph, the Guest is requested to pay an accommodati on deposit fixed by the Ryokan/Hotel within the limits of Basic Accommodation C harges covering the Guest's entire period of stay (3 days when the period of stay e xceeds 3 days) by the date specified by the Ryokan/Hotel.

3.The deposit shall be first used for the Total Accommodation Charges to be paid by the Guest. then secondly for the cancellation charges under Article6 and thirdly for the reparations under Article18 if applicable, and the remainder, if any, shall be refunded at the time of the payment of the Accommodation Charges as stated in Article12.

4.When the Guest has failed to pay the deposit by the date as stipulated in Paragra ph 2 the Ryokan/Hotel shall treat the Accommodation Contract as invalid. However, the same shall apply only in the case when the Guest is thus informed by the

Ryokan/Hotel when the period of payment of the deposit is specified. Article4 (Special Contracts Requiring No Accommodation Deposit)

1.Not with standing the provisions of Paragraph2 of the preceding Article, the Ryo kan/Hotel may enter into a special contract requiring no accommodation deposit aft er the Contract has been concluded as stipulated in the same Paragraph.

2.In the case when the Ryokan/Hotel has not requested the payment of the deposit as stipulated in Paragraph 2 of the preceding Article and/or has not specified the da te of the payment of the deposit at the time the application for an Accommodation Contract has been accepted, it shall be cost rued as that the Ryokan/Hotel has acce pted a special contract prescribed in the preceding Paragraph.

Article5 (Refusal of Accommodation Contracts)

1.The Ryokan/Hotel may not accept the conclusion of an Accommodation Contract under any of the following cases;

(1) When the application for accommodation does not conform with the provisions of these Teams and Conditions;

(2)When the Ryokan/Hotel is fully booked and no room is available;

(3)When the Guest seeking accommodation is deemed liable to conduct himself in a manner that will contravene the laws or act against the public order or good mor als in regard to his accommodation;

(4)When the Guest seeking accommodation is a gangster, a gang affiliate or the person concerned, other antisocial powers

(5)When the Guest seeking accommodation is a group of a public

corporation or others that a gang or a gangster influences operation

(6)When the Guest seeking accomodation is a member of public corporation t hat includes any gangstar or falls under gang.

(7)When the Guest seeking accomodation does a behavior to give a remarkable nuisance to

other hotel guests

(8)When the Guest seeking accomodation performe a violent demand act or request any unreasonable burden more than rational ranges.

(9)When the Guest seeking accommodation can be clearly detected as carrying an infectious disease

(10)When the Ryokan/Hotel is requested to assume an unreasonable burden in regar d to his accommodation;

(11) When the Ryokan/Hotel is unable to provide accommodation due to natural cal amities, disfunction of the facilities and/or other unavoidable causes;

(12)When the provisions of Artcle7 of kyoto Prefectural Ordinance are applicable. Article6 (Right to Cancel Accommodation Contracts by the Guest)

1.The Guest is entitled to cancel the Accommodation Contract by so notifying the Ryokan/Hotel.

2.In the case when the Guest has cancelled the Accommodation Contract in whole or in part due to causes for which the Guest is liable(except in the case when the Ryokan/Hotel has requested the payment of the deposit during the specified period as prescribed in Paragaph 2 of Article 3 and Guest has cancelled before the payme nt), the Guest shall pay cancellation charges as listed in the attached Table No.2. However, in the case when a special contract as prescribed in Paragraph 1 of Articl e4 has been concluded, the same shall apply only when the Guest is informed of th eobligation of the payment of the cancellation charges in case of cancellation by th e Guest.

3.In the case when the Guest does not appear by 8p.m. of the accommodation date (2 hours after the expected time of arrival if the Ryokan/Hotel is notified of it) wit hout an advance notice, the Ryokan/Hotel may regard the Accommodation Contract as being cancelled by the Guest.

Article7 (Right to Cancel Accommodation Contracts by the Ryokan/Hotel)

1.The Ryokan/Hotel may cancel the Accommodation Contract under any of the foll owing cases:

(1)When the Guest is deemed liable to conduct and/or have conducted himself in a manner that will contravene the laws or act against the public order or good morals in regard to his accommodation:

(2) A gang or a gangster

(3) a group of a public corporation or others that a gang or a gangster influe nces operation

(4) Member of public corporation that includes any gangstar or falls under gang

(5)When the Ryokan/hotel or their staff is performed a violent demand act or requested any unreasonable burden more than rational ranges

(6)When the guest does not obey verboten of the use rule that this building establishes (7)When the Guest can be clearly detected as carrying an infectious disease;

(8)When the Ryokan/Hotel is requested to assume an unreasonable burden in regard to his accommodation;

(9)When the Ryokan/Hotel is unable to provide accommodation due to natural cala mities and/or other causes of force majeure;

(10)When the provisions of Article 5of Kyoto Prefectural Ordinance are applicable; (11)When the Guest does not observe prohibited actions such as smoking in bed, m ischief to the firefighting facilities and other prohibitions of the Use Regulations sti pulated by the Ryokan/Hotel (restricted to particulars deemed necessary in order to avoid the causing of fires).

2.In the case when the Ryokan/Hotel has cancelled the Accommodation Contract in accordance with the preceding Paragraph, the Ryokan/Hotel shall not be entitled to charge the Guest for any of the services in the future during the contractual period which he has not received.

Article8 (Registration)

1.The Guest shall register the following particulars at the front desk of the Ryokan /Hotel on the day of accommodation:

(1)Name, age, sex, address and occupation of the Guest(s);

(2)For non-Japanese: nationality, passport number, port and date of entry into Japa n;

(3) Date and estimated time of departure; and

(4) Other particulars deemed necessary by the Ryokan/Hotel.

2.In the case when the Guest intends to pay his Accommodation Charges prescribed in Article12 by any means other than Japanese currency, such as treveler's cheque s, coupons or credit cards, these credentials shall be shown in advance at the time of the registration prescrbed in the preceding Paragraph.

Article9 (Occupancy Hours of the Guest Rooms)

1.The Guest is entitled to occupy the contracted guest room of the Ryokan/Hotel fr om 2:00P.M. to 11:00A.M. the next morning. However, in the case when the Guest is accommodated continuously, the Guest may occupy it all day long, except for th e days of arrival and departure.

2. The Ryokan/Hotel may, notwithstanding the provisions prescribed in the precedin

g Paragraph, permit the Guest to occupy the room beyond the time prescribed in th

e same Paragraph.

In this case, extra charges shall be paid as follows:

(1) Up to 3 hours: 30% of the equivalent in the sum to the room charge;

(2) Up to 6 hours: 60% of the equivalent in the sum to the room charge;

(3) More than 6 hours: 100% of the equivalent in the sum to the room charge.

3. The equivalent in the sum to the room charge prescribed in the preceding

Paragraph shall be 70% of the Basic Accommodation Charges

Article10(Observance of Use Regulations)

1.The Guest shall observe the Use Regulations established by the Ryokan/Hotel. Article11 (Business Hours)

The business hours of the main facilities, etc. of the Ryokan/Hotel are as follows, a nd those of other facilities, etc. shall be nottified in detail by brochures as provided notices displayed in each place, service directories in guest rooms and others.

(1) Service hours of front desk, cashier's desk, etc. A Closing time 0:00A.M

B Front service 7:00A.M. to 9:00P.M.

(2) Service hours(at facilities) for dining, drinking, etc.

A Breakfast 7:30A.M. to 9:30A.M.

B Dinner

B Dinner

C Other meals, drinks,etc.

loby-self service 6:00A.M. to 24:00P.M. (3)Service hours of auxiliary facilities

A Souvenir Shop kotori \$\$8:00A.M. to 9:00P.M. 2.The business hours specified in the preceding Paragraph are subject to temporary

changes due to unavoidable causes of the Ryokan/Hotel.

5:30P.M. to 9:00P.M.

In such a case, the Guest shall be informed by appropriate means.

Article12(Payment of Accommodation Charges)

1.The breakdown of the Accommodation Charges, etc. that the Guest shall pay is a s listed in the attached Table No.1.

2. Accommodation Charges, etc. as stated in the preceding Paragraph shall be paid with Japanese currency or by any means other than Japanese currency such as trave ler's cheques, coupons or credit cards recognized by the Ryokan/Hotel at the front desk at the time of the departure of the Guest or upon request by the Ryokan/Hotel.

3. Accommodation Charges shall be paid even if the Guest voluntarily does not util ize the accommodation facilities which have been provided for him by the Ryokan/ Hotel and are at his disposal.

Article13 (Libilities of the Ryokan/Hotel)

1.The Ryokan/Hotel shall compensate the Guest for the damage if the Ryokan/Hot el has caused such damage to the Guest in the fulfillment or the nonfulfillment of t he Accommodation Contract and/or related agreements. However, the same shall no t apply in cases when such damage has been caused due to reasons for which the Ryokan/Hotel is not liable.

2.Even though the Ryokan/Hotel has received the "PASS MARK" (Certificate of Ex cellence of Fire Prevention Standard issued by the fire station). furthermore, the Ryo kan/Hotel is covered by the Ryokan/Hotel Liability Insurance in order to deal with unexpected fire and/or other disasters.

Article14 (Handing When Unable to Provide Contracted Rooms)

1. The Ryokan/Hotel shall, when unable to provide contracted rooms, arrange accom modation of the same standard elsewhere for the Guest insofar as practicable with t he consent of the Guest.

2.When arrangement of other accommodation can not be made notwithstanding the provisions of the preceding Paragraph, the Ryokan/Hotel shall pay the Guest a com pensation fee equivalent to the cancellation charges and the compensation fee shall be applied to the reparations. However, when the Ryokan/Hotel cannot provide acc ommodation due to the causes for which the Ryokan/Hotel is not liable, the Ryoka n/Hotel shall not compensate the Guest.

Article15(Handing of Deposited Articles)

1.The Ryokan/Hotel shall compensate the Guest for the damage when loss, breakag e or other damage is caused to the goods, cash, or valuables deposited at the front desk by the Guest, except in the case when this has occurred due to causes of forc e majeure. However, for cash and valuables, when the Ryokan/Hotel has requested the Guest to report its kind and value but the Guest has failed to do so, the Ryoka n/Hotel shall compensate the Guest within the limit of 150,000 yen.

2.The Ryokan/Hotel shall compensate the Guest for the damage when loss, breakag e or other damage is caused, through intention or negligence on the part of the Ryo kan/Hotel, to the goods, cash or valuables which are brought into the premises of t he Ryokan/Hotel by the Guest but are not deposited at the front desk.

However, for articles of which the kind and value have not been reported in advan ce by the Guest, except in case of the damage caused through intention or gross ne gligence on the part of the Ryokan/Hotel shall compensate the Guest within the lim it of 150,000 yen.

Article16 (Custody of Baggage and/or Belongings of the Guest)

1.When the baggage of the Guest is brought into the Ryokan/Hotel before his arriv al, the Ryokan/Hotel shall be liable to keep it only in the case when such a request has been accepted by the Ryokan/Hotel. The baggage shall be handed over to the Guest at the front desk at the time of his check-in. 2.When the baggage or belongings of the Guest is found left after his check-out, an d the ownership of the article is confirmed, the Ryokan/Hotel shall inform the own er of the article left and ask for further instructions. When no instruction is given t o the Ryokan/Hotel by the owner or when the ownership is not confirmed, the Ryo kan/Hotel shall keep the article for 7 days including the day it is found, and after t his period, the Ryokan/Hotel shall turn it over to the nearest police station.

3.The Ryokan/Hotel's liability in regard to the custody of the Guest's baggage and belonings in the case of the preceding two Paragraphs shall be assumed in accordan ce with the provisions of Paragraph 1 of the preceding Article in the case of Paragraph 1, and with the provisions of Paragraph 2 of the same Article in the case of Paragraph 2.

Article17 (Liability in regard to Parking)

1.The Ryokan/Hotel shall not be liable for the custody of the vehicle of the Guest when the Guest utlizes the parking lot within the premises of the Ryokan/Hotel, as it shall be regarded that the Ryokan/Hotel simply offers the space for parking, whet her the key of the vehicle has been deposited with the Ryokan/Hotel or not. Howev er, the Ryokan/Hotel shall compensate the Guest for the damage caused through int ention or negligence on the part of the Ryokan/Hotel in regard to the management of the parking lot.

Article18(Liability of the Guest)

1.The Guest shall commpensate the Ryokan/Hotel for the damage caused through in tention or negligence on the patt of the Guest.

2.A child's charge applies to children attending elementary school of ages(up to 12 years of age) and under. 70% of the adult charge shall be required when meals and bedding comparable to those for the adult are provided to such children, 50% shall be required when meals and bedding for children are provided and 30% when only bedding for children is provided. For an infant to whom meals and bedding are no t provided, 3150yen shall be charged.
